

Contract Compliance

Monitor and manage actual DBE participation relative to contract goals

Publicly funded contracts come with big responsibilities for the contract-owning agency and the prime contractor. Disadvantaged Business Enterprise (DBE) and Airport Concessions Disadvantaged Business Enterprise (ACDBE) programs have requirements and standards that need to be met in order to comply. Typically, a percentage of DBEs must be included in the overall hiring for the project. If not enough DBEs are found or they do not meet requirements, the prime contractor must prove they attempted to find them. Non-compliance with DBE requirements can lead to serious penalties, including loss of federal funding, legal action, contract termination, corrective action plans and reputational damage. Additionally, consistent failure to meet DBE rules may result in ineligibility for future federally funded projects or procurements.

Each contract can be worth millions, if not billions, of dollars and includes dozens, if not hundreds, of subcontractors. It can be challenging to track all of the vendors, their certifications, work specialties, budget allotment, payments, and project progress. Typically, contractors have used spreadsheets, paper-based documents, various means of communication (e.g. email, phone calls, faxes), manual data entry and math calculations to track and report on their efforts. Manual processes and spreadsheets simply cannot keep up with constantly changing and expanding federal and state regulations, including multi-tier prompt payment tracking. In addition to being slow and cumbersome, homegrown systems are prone to error and can quickly fall out of regulatory alignment.

To mitigate risk, organizations need a modern system that promotes contract compliance through proven processes that efficiently monitor and document actual participation of certified DBE subcontractors, suppliers, and trucking firms. The ideal platform enables organizations to fully document vendor participation against contract goals in a wide range of scenarios, including on-call contracts, multi-agency contracts, and those that have deep supplier and subcontractor-tiered structures. At the same time, it should reduce administrative burden by enabling firms to directly validate payment information and other details related to the work performed. Ideally, the system is easy to access and is continually updated by a U.S.-based development team to ensure the ability to adapt to expanding program goals and ongoing compliance with changing rules. It should also have proven scalability to successfully handle complex projects across large organizations.

The B2Gnow Contract Compliance module is a key tool for efficiently managing the key performance metrics of business diversity management programs. With this module, agencies and primes can digitize required documents and data, automatically validate certification status, match vendors to approved commodity codes, and calculate actual vendor participation versus contract goals while capturing lower-tier utilization up to ten tiers deep. Prime and subcontractor payments are collected, and direct subcontractor payment confirmation on active contracts is facilitated monthly or quarterly to minimize the risk of certified vendor participation falling below contract goals.

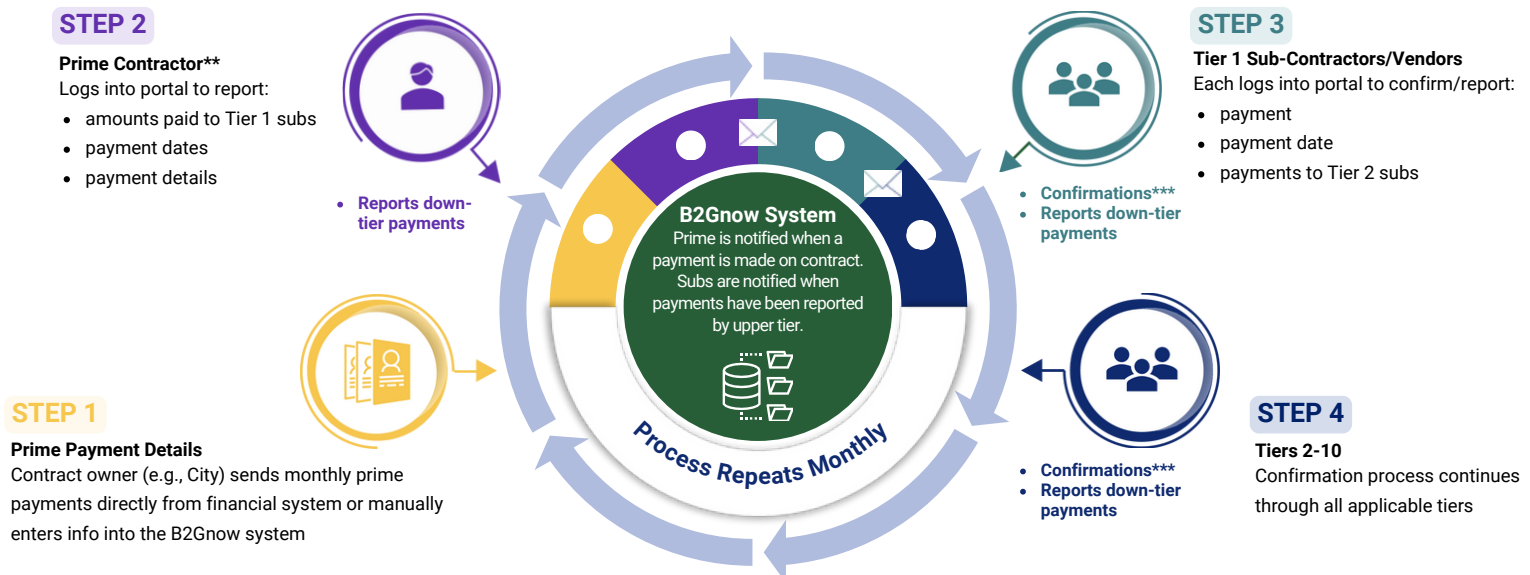
- **New Contract Creation** - Create new contracts and set the contract budget, start and end dates, and diversity participation goals
